# 2024 NACD FLY-IN ADVOCACY DAY IN WASHINGTON, D.C.

**Washington D.C.**—On March 20, 2024, several partners from Maryland participated in the National Association of Conservation Districts (NACD) annual Fly-In, where members visited Washington D.C. and met with legislators to discuss policies that affect conservation and farmers from across the country.

Maryland Association of Soil Conservation District's (MASCD) president and Talbot Soil Conservation District Chairman John Swaine III, along with Shawn Smith, Talbot SCD Manager, Suzy Daubert, NRCS State Conservationist, Jen Nelson, MASCD Executive Director and Rudy Arredondo, President of the National Latino Farmers and Ranchers Alliance, met with several legislators and aids on the hill to discuss important conservation priorities.

Legislators were given informational packets that included the following:

#### The Role of the Conservation Districts

Conservation districts work with farmers and landowners to develop and implement conservation projects that are tailor-made for their individual operations. Each county in Maryland has a conservation district that works closely with USDA's Natural Resources Conservation Service, Maryland Department of Agriculture and other partners to provide technical and financial assistance to our cooperators and get projects on the ground. In 2023, Maryland's Conservation Partners leveraged \$28.62 million in federal conservation funds with \$35.6 million in state funds to adopt conservation practices, including:

• 395,000 acres of cover crops to improve soil health and prevent nutrients from entering our rivers and the Chesapeake Bay

- 1,246 Soil Conservation and Water Quality Plans to protect 126,293 acres
- *2,196 best management practices, such as animal waste management systems and riparian and grass buffers*

#### How Our Elected Officials Can Help

Thank you for passing a spending bill that funds USDA and puts an end to continuing resolutions that created uncertainty for conservation operations.

- Pass a bipartisan Farm Bill in 2024 so that our farmers have confidence in making plans that keep their operations profitable and productive.
- Keep conservation investments through the Inflation Reduction Act in the conservation sections of the Farm Bill.

• Avoid one-size-fits-all

policies within programs. Grant greater flexibility and authority to state and local partners to execute technical assistance agreements and leasing agreements that are the best fit for their locality and allow partners to remain co-located.

- Remove language in the Agricultural Conservation Easement Program related to unfunded liabilities that prohibits states from partnering with the program. In addition, the same state-level authority noted above would streamline the process for landowners and encourage greater participation in the program.
- Keep flood prevention and drainage infrastructure front of mind as critical issues for East Coast states to be resilient to climate change impacts.





implement practices and activities in their conservation plan that can lead to cleaner water and air, healthier soil and better wildlife habitat, all while improving their agricultural operations. EQIP helps producers make conservation work for



them. Financial assistance for practices may be available through EQIP. Some producers may also qualify for advance payment.

**NRCS offers technical assistance at no cost.** Producers can use our personalized advice and information, based on the latest science and research, to make informed decisions about their land. Technical Service Providers (TSP) can also help producers plan, design and implement conservation practices or develop conservation activity plans to improve their agricultural operations.

The first step is to contact the Talbot Soil Conservation District. An NRCS certified conservation planner will schedule a visit to your property. They will walk the land with you to discuss your goals and review any resource concerns. Following the site visit, the conservation planner will develop a conservation plan that includes a variety of conservation practices or activities to address the resource concerns and management goals discussed.

## What is a Soil Conservation & Water Quality Plan and why should I have one for my farm?

**Soil Conservation and Water Quality Plans** (SCWQP) or **Conservation Plans** are a valuable tool for farmers and landowners to manage resources and improve profitability.

A conservation plan is a working document designed to fit each individual farmer's needs while protecting and conserving their soil and water resources.

**Conservation plans are not mandatory unless all or part of the farm falls within the Chesapeake Bay Critical Area** or you are applying for or currently participate in an agricultural land preservation program, or participate in any state or federal cost share programs.

If you are interested in developing a conservation plan for your farm,

please contact one of our conservation planners to set up an on-farm visit. The planner will need to walk the farm and take notes on current farming practices and identify any resource issues which may need to be addressed. These plans are free and should be updated at least every 10 years.

## **CONSERVATION SPOTLIGHT**

**Rock lined outlets** (NRCS code 468) are used to accomplish one or more of the following purposes: **provide safe conveyance of runoff** from conservation practices or other flow concentrations without causing erosion or flooding, **prevent or stabilize existing gully erosion** or scour, or to **protect and improve water quality** If you have an erosive area in the field contact one of our planners at 410-822-1577 x 3.
